Operational since 1 July 2024, the Centre will implement key recommendations from *Invested: Australia's Southeast Asia Economic Strategy to 2040* and promote greater Southeast Asia literacy in Australia. The Centre will deliver initiatives that strengthen business, education, cultural and community connections between Australia, ASEAN countries and Timor-Leste.

Emerging leaders program

The program supports three cohorts of 25 early-to-mid-career professionals across three thematic sectors. 22 professionals from ASEAN countries and Timor-Leste and three from Australia, are brought together to build networks, deepen cross-cultural connections and develop strategic leadership capabilities.

Each course runs over a three-month period and comprise virtual sessions and a one-week component in Australia.

The program offers a balance of theoretical and practical insights, engagement with external bodies, cultural and social activities, networking and development of a return-to-work plan.

Objectives

The Emerging Leaders Program will support you to:

- expand your knowledge, skills and experience in the sector you work in
- learn from diverse industry experts and program participants through interactive sessions and discussions
- be immersed in cultural experiences and activities

- build connections with other participants from the ASEAN region, Timor-Leste and Australia through formal and informal activities
- network with individuals and organisations relevant to your area of work
- discover Australian First Nations perspectives and experiences through a Welcome to Country and Smoking Ceremony
- explore issues of importance to women, people living with disability and other traditionally marginalised groups
- contribute to efforts in the ASEAN region and Timor-Leste to tackle identified issues, through implementing a return-to-work plan and leveraging your new connections.

Operational since 1 July 2024, the Centre will implement key recommendations from *Invested: Australia's Southeast Asia Economic Strategy to 2040* and promote greater Southeast Asia literacy in Australia. The Centre will deliver initiatives that strengthen business, education, cultural and community connections between Australia, ASEAN countries and Timor-Leste.

Short Courses

The Short Courses support Recommendation 35 of *Invested Australia's Southeast Asia Economic Strategy to 2040*, to "offer two-way tertiary scholarships in the resources sector to address skills shortages and gender equality and enhance Southeast Asia's technical capacity".

The ASEAN-Australia Centre Short Courses aims to build technical capacity, knowledge and expertise of participants in the STEM and resources sectors. These courses will support two cohorts of 22 early-to-mid-career professionals from ASEAN countries and Timor-Leste across the thematic areas of **Women in STEM and Resources and Energy Transition**.

Each of the two Short Courses will run over a three-month period and comprise virtual sessions (four half-day sessions) and a two-week stay in Australia.

The program offers a balance of theoretical and practical insights, industry visits and networking events allowing participants to experience Australian "best practice" first-hand, introductions to Australia's cultural heritage and development of a return-to-work plan.

Objectives

The Short Courses will support you to:

- expand your knowledge, skills and experience in your relevant sector
- learn from diverse industry experts and program participants through interactive sessions
- be immersed in cultural experiences and discover Australian First Nations perspectives
- build connections with other participants from the ASEAN region and Timor-Leste through formal and informal activities
- network with individuals and organisations relevant to your area of work
- explore issues of importance to women, people living with disability and other traditionally marginalised groups
- contribute to efforts in the ASEAN region and Timor-Leste to tackle identified issues, through implementing a return-to-work plan and leveraging your new connections.
